




- ➤ Procedure: To file an offline grievance, one must submit a letter of complaint in one of the suggestion boxes that have been placed across campus.




#### SCREENSHOT OF GRIEVANCE REDRESSAL PROVISION IN COLLEGE WEBSITE






> Mechanism for anti-ragging is done through helpline numbers
